DIRECTIONS FOR USE:

This product is designed to be used in conjunction with United 248 BIO BRIGADE DEVOUR-DX to treat drains utilized in dialysis treatment. Treat each drain affected at the end of each working day.

After the final disinfecting and cleaning routine performed on dialysis equipment feeding into the drain, allow 15 minutes before treating the drain with United 248 and **United 247**. After 15 minutes has passed, flush drain with clean water. Then pour in 4 ounces of United 248 to keep drains running freely.

Once United 248 has been fed into drains, pour 4 ounces of **United 247 BIO BRIGADE DRAIN MEMBRANE** into the drain. The product will float on the top, creating a membrane-like cap to control odors, while also working to eliminate any drain flies that feed in the drain.

Note: If spilled on floor, **United 247** may make floor surfaces slippery. Use a mild detergent/water solution to clean **United 247** from floor surfaces.
